The athletic booster clubs from our six high schools, Seven Lakes, Morton Ranch, Cinco Ranch, Katy, Mayde Creek, and Taylor are preparing to begin selling ad spaces for the 2010 Katy ISD football programs.

Each school booster club will be selling ad spaces for all high school football programs to help generate revenue for the support of our KISD sport programs. We will host a minimum of 30 varsity football games next season at Rhodes Stadium. During that season your ad in the football program will be exposed to more than 100,000 fans attending these thirty games.

The funds generated as a result of these ad sales will go directly to the booster club of each high school to be used to support all girls and boys athletic teams on that campus.


As a result of purchasing a one-half page or full page ad, each vendor will receive two passes good for general admission for "holder only" to any Katy ISD regular season athletic contest played inside the boundaries of our district. This pass is good at junior high and high school regular season sporting events, but it is not valid at playoff contests.

Advertisers may choose to place an ad in any one or all of our high school football programs.
